Software License for Helix(tm) Mobile Session Manager

IMPORTANT -- READ CAREFULLY: This License Agreement ("License Agreement") is a legal agreement between you (either an individual or an entity) ("You" or "Licensee") and RealNetworks, Inc. and its suppliers and licensors (collectively "Real") for Real's Helix Mobile Session Manager, which includes computer software and associated media and printed materials ("Software"). The Software may include any of the following Real products including any combination of such products and Alpha, Beta, trial, and pre-release versions of the products (collectively, "Real Products"): Helix Session Manager. You may install only ONE copy of the Software. By choosing "Accept," installing, copying or otherwise using the Software, you agree to be bound by the terms of this License Agreement. If you do not agree to the terms of this License Agreement, select "Cancel" or "No" and/or do not install the Software.

YOU AGREE THAT YOUR USE OF THE SOFTWARE ACKNOWLEDGES THAT YOU HAVE READ THIS LICENSE, UNDERSTAND IT, AND AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS.

1. **ELIGIBILITY FOR THIS LICENSE.** This license is only available to organizations using this software to provide content to consumers via an Operator or Media Company or to organizations that provide voice and/or data network services to consumers and businesses through wireless wide area network technologies including but not limited to GPRS, Edge, CDMA2000, UMTS, EVDO and WiMax. Eligible organizations may either own or lease network infrastructure (MVNO). As used in this License Agreement, "Media Company" means an entity that provides text, audio or video programming to distributors or direct to consumers in exchange for fees or based on an advertising business model, and "Operator" means an organization that provides voice and/or data network services to consumers and businesses through wireless wide area network technologies, including but not limited to GPRS, Edge, CDMA2000, UMTS, EVDO and WiMax; eligible organizations may either own or lease network infrastructure (MVNO).

2. **GRANT OF LICENSE.** Subject to the provisions contained herein and in return for the payment of the requisite License Fees for the Software, Real hereby grants Licensee a non-exclusive, non-transferable, perpetual, worldwide license to use and install the Software as follows:

(a) **Installation.** You may install and enable one operational copy of the Software ("Operational Copy"). You may also install one (1) additional copy ("Redundant Copy") of the Software on another computer, provided that such Redundant Copy is used only as

a "hot back-up" system, without any traffic on the back-up system during the use of the Operational Copy. If you install and enable additional copies of the Software, You must pay additional license fees. Please contact Real or visit our Website at <http://www.realnetworks.com>.

(b) Helix Session Manager Use. If You have purchased a license for the Helix Session Manager, You may use your installed copy of the Software to interoperate with one server running Helix Server software or Helix Mobile Server software (each a "Server") and your business systems, and may use the following features of the Software: client control and logging. **YOU MAY NOT ENABLE ANY OTHER FEATURES.** You may increase the number of Servers with which the Software can interact by purchasing additional Helix Mobile Session Manager licenses from Real. The number of Servers with which the Software can interact is also limited by the hardware, software and bandwidth configurations of the CPU on which the Software is installed. You may not attempt to use the Software to circumvent the security mechanisms limiting the number of Servers with which the Software can interact.

3. **OTHER RIGHTS AND LIMITATIONS.** Evaluation Software. If you have received the Software from RealNetworks for evaluation purposes, you may not use the Software beyond the time limit set by the Software license key. Notice to Users. You agree to inform all users of the Software, other than End Users receiving Streams, of the terms of this License Agreement. Dual-Media Software. You may receive the Software in more than one medium (e.g., by electronic distribution and on CD-ROM). Regardless of the type or size of medium you receive, you may use only install one copy of the software. No Copying. You may not copy the Software except that you may make a single copy of the software for archival purposes only, provided such copy must contain all of the original Software's proprietary notices. You may make unlimited copies of the Documentation for your internal use in connection with use and support of the Software, provided that you may not modify the Documentation or remove any proprietary notices. No Modifications or Reverse Engineering. You may not modify, translate, reverse engineer, decompile or disassemble (except to the extent that this restriction is expressly prohibited by applicable law), or create derivative works based on the Software. No Resale, Rental or Transfer. You may not rent, lease, sell, or transfer the Software or documentation without RealNetworks' express written consent, which RealNetworks may withhold in its discretion. Audit Rights. You shall permit RealNetworks to audit your compliance with this License Agreement, as RealNetworks deems reasonably necessary

4. **SOFTWARE OWNERSHIP.** This is a license agreement and NOT an agreement for sale. Title, ownership rights and intellectual property rights in and to the Software (including any images, animations, video, audio, music, and text incorporated into the Software), accompanying printed materials, and any copies you are permitted to make herein are owned by RealNetworks or its suppliers and are protected by United States copyright law and international treaty provisions. Your rights to use the Software are specified in this License Agreement, and RealNetworks retains all rights not expressly granted to you in this License Agreement. Nothing in this License Agreement constitutes a waiver of RealNetworks' rights under U.S. or international copyright law or any other federal or state law.

5. **BETA RELEASE VERSIONS.** In the event that the Software is a beta release version, the terms of this Section shall apply. Your license to use the Software expires 120 days after installation (or such other period as indicated by the Software) and the Software may cease to function. The Software you are receiving may contain more or less features than the commercial release of the Real Product that Real intends to distribute. While Real intends to distribute a commercial release of the Software, Real reserves the right at any time not to release a commercial release of the Software or, if released, to alter features, specifications, capabilities, functions, licensing terms, release dates, general availability or other characteristics of the commercial release. You agree that the Beta Release Versions are not suitable for production use and may contain errors affecting their proper operation. You agree that you will not do anything to circumvent or defeat the features designed to stop the Software from operating after the license expires.

6. **SOFTWARE UPGRADES.** Real may develop or issue upgraded versions of the Software from time to time. At its sole option, and for a fee to be determined, Real may make such upgrades available to you. If the Software you have is labeled as an upgrade, you must be properly licensed to use a product identified by Real as being eligible for the upgrade in order to use the Software. Software labeled as an upgrade replaces and/or supplements the product that formed the basis for your eligibility for the upgrade, and following the upgrade you may use the resulting Software only in accordance with the terms of this License Agreement. If the Software is an upgrade of a component of a package of software programs that you licensed as a single product, the Software may be used and transferred only as part of that single product package and may not be separated for use on more than one computer.

(a) For Production versions of the Software, the following terms apply:

LIMITED WARRANTY. Real warrants that for a period of ninety (90) days from the date of acquisition the Software, if operated as directed, will substantially achieve the functionality described in the Documentation. Real does not warrant however that your use of the Software will be uninterrupted or that the operation of the Software will be error-free or secure. Real also warrants that the media containing the Software, if provided by Real, is free from defects in material and workmanship and will so remain for ninety (90) days from the date you acquire the Software.

(i) **No Other Warranties. NO OTHER WARRANTIES: TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW REAL AND ITS SUPPLIERS DISCLAIM ALL OTHER WARRANTIES EITHER EXPRESS OR IMPLIED INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE WITH REGARD TO THE SOFTWARE, THE ACCOMPANYING WRITTEN MATERIALS AND ANY ACCOMPANYING HARDWARE.** If any modifications are made to the

Software by you during the warranty period; if the media is subjected to accident abuse or improper use; or if you violate the terms of this License Agreement, this warranty shall immediately terminate. This warranty shall not apply if the Software is used on or in conjunction with hardware or Software other than the unmodified version of hardware and Software with which the Software was designed to be used as described in the Documentation. THIS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS; YOU MAY HAVE OTHER RIGHTS THAT VARY FROM STATE/JURISDICTION TO STATE/JURISDICTION.

(ii) Customer Remedies. Real's sole liability for a breach of this warranty shall be in Real's sole discretion: (i) to replace your defective media; or (ii) to advise you how to achieve substantially the same functionality with the Software as described in the Documentation through a procedure different from that set forth in the Documentation; or (iii) if the above remedies are impracticable, to refund the license fee, if any, you paid for the Software. If Real does not consent to assignment of this Agreement to the new or acquiring entity in such merger or acquisition, Real may terminate this Agreement on thirty (30) days' written notice. Both parties shall perform under this Agreement until such termination is effective.
